MSG LEADERS MEET IN HONIARA

The 20th MSG Leaders Summit held in Honiara. Solomon Islands on 25-26 June, was chaired by Hon. Manasseh Sogavare, Prime Minister of Solomon Islands, and was attended by Mr Victor Tutugoro, Spokesperson of FLNKS, Vorege Bainimarama, Hon. Prime Minister of Fiji; Hon. Peter O'Neill, Prime Minister of PNG; and Mr Johnson Naviti, Director General (DG), Office of the Prime Minister, who represented the Prime Minister of Vanuatu. The Summit was centered on the theme, Let's build a strong Melanesia in the Pacific where peace, progress and prosperity is ensured and sustained for all.

While public attention focused on the approval for the admission of the United Liberation Movement for West Papua as an Observer member, and of Indonesia as an Associate member representing the five Melanesian Provinces in their country, Leaders also made key decisions on the work programme of the Secretariat as

LEADERS SIGN INSTRUMENTS OF COOPERATION

MSG Leaders signed the following Instruments of Cooperation at their Summit in Honiara on 26 June to promote, coordinate and strengthen intra-MSG relations, in support of Members' shared goals of economic growth, sustainable development, good governance, peace and security:

- 1. Agreement Establishing MSG (Revised 2015) is the main legal document governing relations between members and the affairs of the MSG Secretariat.
- 2. Declaration on the MSG 2038 Prosperity for All Plan is the policy framework to achieve MSG's Vision and Mission of enhanced sub-regionalism and integration, while its Implementation Framework serves as the operational guideline for the Plan's Objective and Strategies and to guide future MSG resource allocation and programming.
- 3. Agreement Establishing the Regional Police Academy aims to strengthen police cooperation and encourage specialized training for police forces from Member Countries to be able to address law and order and security threats in the region.
- 4. Framework Agreement for the MSG Formed Police Unit provides a framework for strengthening security and police cooperation between Members to address law and order and security threats.

- 5. MOU on the Humanitarian and Emergency Coordination Centre focuses on natural disasters, man-made disasters like oil spills, civil aviation or maritime accidents and complex emergencies.
- 6. Declaration on Transshipment of Nuclear Wastes and Trans-bounday Movement of Hazardous Wastes (Revised 1995 Lakatoro Declaration) encourages dialogue on nuclear transshipment that usually passes through MSG Exclusive Economic Zones and the risk of spillage due to likely accident or natural disaster in the region.
- 7. MOU on Technical Cooperation in Coastal Fishery and Aquaculture Development between Members of the MSG facilitates a collaborative approach to build Members' capabilities and resources in a coordinated and efficient way in the areas of sustainable coastal fisheries and aquaculture development.
- 8. MSG Roadmap for Inshore Fisheries Management and Sustainable Development provides a strategic direction on the way forward that is relevant to Members' inshore fisheries sectors, policies and legislation and provides a detailed structure for the implementation within the inshore fisheries sector.

- 9. Declaration on Combating Domestic and Family Violence recognises the importance of a regional approach to combating domestic and family violence at the national and regional level, such as in advancing the role of MSG in complementing the work of relevant international and regional partners.
- 10. **MOU** on Sports Cooperation promotes and develops cooperation in sports exchange programs, including coaches and technical officials, and direct financial support for the preparation of major regional sports events.
- 11. Revival of the Melanesian Soccer Cup which was last held in 2000 in Suva, Fiji will now be brought back to the mainstream of MSG events, with participation limited to MSG citizens given the increasing number of foreigners playing in the League competitions in Member countries.

The above Instruments of Cooperation are notably consistent with the overarching theme of the 20th MSG Leaders Summit, that is, "Let's build a strong Melanesia in the Pacific where peace, progress and prosperity is ensured and sustained for all". LEADERS DIRECT CONCLUSION OF TRADE NEGOTIATIONS

This year, 2015, will be a monumental one for the Trade Negotiations process that Members have been engaged in, since the revised MSG Trade Agreement (MSGTA3) is to be signed by November. It follows the decision of Leaders at their recent Summit in Honiara where they "Directed trade officials to continue to support activities towards concluding negotiations on the MSGTA3 legal text by October, ahead of the planned TMM tentatively scheduled for November 2015". Their decision harmonises with the Trade Ministerial mandate under the Port Moresby Declaration for "Concluding MSGTA3 negotiations on Goods and Services by 2015" and will, most importantly help towards the achievement of a Melanesian Free Trade Area in line with the first commitment under the Declaration, namely "Achieving a Free Trade Area by 2017".

The Secretariat has been actively engaged in providing Members with advisory support upon their request and, through the Technical Working Group Negotiations (TWGN) on both Goods and Services such as were convened in Port Vila, Vanuatu last April. In addition and following the Trade Officials' decision at their April meeting, the Secretariat's Trade Economist/Legal (TEL), Mr Petros Shayanowako, joined the PSD Mission Team during their incountry consultations (see Page 3) to discuss with national stakeholders including Government officials, private sector representatives and non-state actors, developments pertaining to the MSGTA3, with particular focus on the revision of the Rules of Origin under the MSGTA3. Another round of TWGNs by Trade Officials will be held in Nadi, Fiji during the week of 24 August. For any further clarification, Petros can be reached via email, p.shayanowako@msq.int.

EXTENSIVE PSD CONSULTATIONS COMPLETED

Forty-eight days were spent by the PSD Mission Team during their unprecedented series of in-country consultations, which involved six international and 20 domestic flights, four boat rides, and 11 distant trips by road. This took the Team to four capitals, 15 other rural and urban centres, not to mention the cancellation of an inter-island boat trip due to a cyclone warning! In total, 130 meetings were convened, involving 365 stakeholders from the public and private sectors, non-state actors including traditional resource owners plus the media.

The Mission Team was led by Private Sector Development Adviser (PSDA) Mr Henry Sanday and included Consultant Mr Jesoni Vitusagavulu (Vitu) and TEL Mr Petros Shayanowako. They departed from Port Vila on 28 April and finally returned to base on 14 June. Petros' task focused on the Rules of Origin requirements of the MSGTA3, as recommended by Trade Officials last April. Coincidentally, implementing the sixth of 11 commitments under the Port Moresby Declaration (of "mapping out a clear private sector development strategy by 2015") started in Port Moresby itself, followed by trips to Kokopo (then by road to Rabaul) in PNG's maritime Province of East New Britain, then to Lae in Morobe Province and finally, to Mt Hagen in Western Highlands Province.

Outside Honiara in Solomon Islands, the travel to Western Province included boat trips between the Airport and Town in Gizo, and by road between the township of Munda and the fishing port of Noro. The scheduled boat trip from Honiara to Auki in Malaita Province was cancelled due to a cyclone alert in the seas off Southern Malaita.

In Fiji, the Team flew from Suva to Labasa on Vanua Levu before travelling by road to Savusavu via Seaqaqa and Wailevu, and returned to the capital from Savusavu by air. Travel in the Western Division of the main island of Viti Levu, spanning from Nadi to Lautoka, Ba and Tavua, was completed by road.

In Vanuatu, the flight from Port Vila to Luganville on Santo was followed by a 60km evening northward drive to Port Olry and on the following day, the Team took a 40-minute boat ride to Aore Island. Trips to Lenakel, Isangel and the coffee farms on Tanna were taken by road.

Consultations were held with National and Local Government authorities including Provincial and Municipal Councils, the private sector comprising domestic and foreign investors, central and commercial banks and other financial institutions, both formal and informal enterprises from various sectors, cooperatives, women and youth-owned enterprises, peak industry bodies, indigenous and other business associations, churches as well as development partners, regional and international organisations, academia and research institutes. Two special groups that expressed profound appreciation for their inclusion in the consultations were people with disabilities through their respective national and regional bodies, and the national Corrections Services which supervise inmates' rehabilitation. Online submissions were also received from various parties.

Participants of the consultations have been kept up-to-date by the Secretariat with regards to progress on the work being done by Vitu, who has been preparing the Draft MSG PSD Strategy for presentation to the 3rd Heads of Investment Promotion Agencies and Industry Officials Meeting HIPA+IOM) to be held in

Nadi, Fiji on 27 August. Further updates by the Secretariat on the Strategy's development will subsequently be made to the Trade and Economic Officials Meeting (TEOM) on 28 August and the Trade Ministerial Meeting (TMM) on 31 August also in Nadi. Further reviews will take place in the lead-up to the Strategy's final tabling with the Trade Ministers in November.

DG Peter Forau said, "This is a major piece of work for us following Ministerial commitments under the Port Moresby Declaration and the Secretariat wishes to ensure that the final Strategy is a quality document which is realistic in addressing Members' diverse needs." He noted that the Strategy will add value to Members' PSD policy commitments as contained in their respective National Development Strategies, as well as to the Secretariat's resource mobilization plans, "After all, our Leaders at their recent Summit in Honiara, encouraged the Secretariat to work closely with relevant partners in the region on the implementation of the PSD Strategy," DG Forau added. ACTIVE ENGAGEMENTS WITH EU

The Secretariat's recent engagements with the EU included the participation of Capacity Development Adviser, Ms Eleni Tevi and Information Technology & Website Officer, Ms Monica Abau-Sapulai, at the Europe Day celebrations on 09 May in Suva, Fiji. The distribution of publications and audio visual presentations at the MSG booth raised the visibility of MSG as an organisation and of its activities. Next were the 2015 Monitoring and Evaluation of the Strengthening Pacific Economic Integration Through Trade (SPEITT) meeting on 13 May and the 11th EDF Programming meeting on 14 May. Both were attended by Eleni and Program Manager, Trade & Investment (PMTI), Mr John Licht. The 11th EDF will focus on Regional Economic Integration; Sustainable Management of Natural Resources and, Governance, Human Rights and Gender. For the use of 11th EDF resources, emphasis was placed on the need for implementing partners to progress from trade negotiations to actual implementation, and also to ensure inclusiveness so that resources will address the specific interests of minority groups including women and people with special needs. To strengthen capacity on 11th EDF Procurement Procedures and Implementation Requirements, an intensive training similar to previous EDF trainings offered by the EU will be held in Suva, Fiji on 03-13 August. The MOU signed between MSG and PIPSO on 13 May in Suva is a key milestone for the two institutions given their commitment to regional economic integration through PSD. Both are implementing partners of the EU-funded, PIFS-administered SPEITT programme, a component of which is PITAP. The MOU, which DG Peter Forau signed with PIPSO CEO, Mrs Mereia Volavola, was exchanged during the annual SPEITT Steering Committee meeting.

PIFS Deputy SG, Ms Andie Fong Toy, and EU Head of Economic & Social Sectors for the Pacific, Mr Jerome Pons, commended both MSG and PIPSO for their initiative to foster cooperation that addresses common priorities, and to also explore new opportu-

nities for further collaboration, including the pooling of resources for joint initiatives. According to DG Forau, "The MOU will further unleash the potential of our two organisations to better serve our Members as we advance into a new Trade Agreement post-2015." Mrs Volavola acknowledged the importance of joint approaches to enhancing private sector influence on regional and national trade, investment and economic policy issues. "The MOU formalizes the partnership which PIPSO and the MSG Secretariat have developed over the last three years," she noted. The key outcome of the meeting was the matching of Pacific-specific strategies with COLEACP methodologies for use from 2015 onwards. The Secretariat's intervention focused on the significance of the informal economy, trading between adjacent sovereign states and the PSD Strategy that is being developed. WONDER WOMAN: FROM CRISIS TO COPRA, TO BUSES AND HOTELS

Melanesian Tok will be profiling selected individuals who met with the PSD Mission Team, as parts of their inspirational experiences may be replicable elsewhere.

We begin with Ms Ellis Waragat, Managing Director of Kokopo Lodge & Kokopo Tours Ltd based in PNG's island Province of East New Britain. Ellis and her husband lost their jobs during the Bougainville crisis in 1989. They returned home in Kokopo and did odd work including cutting and selling copra, and, as Ellis emphasised, "we saved and saved and saved." Using personal savings, Ellis bought her first 15-seater mini-bus in 1991 to provide public and tourist transportation services. She has since expanded her fleet to seven 15-30 seater mini-buses plus a crane that does contractual work for PNG Power Ltd. Her tours take clients to World War II relics, the famous Tavurvur Volcano that erupted in 1994 and other picturesque settings of Kokopo, Rabaul and other parts of the island.

Due to tourist demand, Ellis ventured into an accommodation facility in her village that was built using timber resources from their ancestral lands. Reflecting on her incredibly trying experiences, Ellis revealed "In July 2006, 13 Australian

Church visitors stayed with us for one week and they ate local food. That started my hotel business, informal and without an official opening."

Unsurprisingly, no commercial bank dared to meet Ellis' financial needs due to her lack of collaterals. Her cries for help to enable the purchase of basic white goods and bedding materials for her village-based hotel were eventually heard by a general finance company, which took the risk and lent K30.000 in response to her loan application of K15,000. She described that loan approval as "It was like I was in Heaven!" The rest is now history as business continues to grow. She has thus become an established formal sector player, a training service provider and mentor to other women and young girls, a speaker at conferences, and an avid contributor to community, provincial and national development. As for her current project, she is concentrating on designing a two-storey 50room hotel to be constructed in downtown Kokopo! Police Commissioners Conclude Conference

MSG Police Commissioners met in Honiara, Solomon Islands on 14 May for their 5th Conference, which was officially opened by Hon. Manasseh Sogavare, Prime Minister of Solomon Islands. The Conference was co-chaired by Royal Solomon Islands Police Force (RSIPF) Commissioner, Mr Frank Prendergast and Mr. Philippe Ajapuhnya, representative of FLNKS. In attendance were Commissioner Bernardus J.J Groenewald of the Fiji Police Force, Assistant Commissioner Jim Wan of the Royal PNG Constabulary, Assistant Commissioner Daniel Rakau of the Vanuatu Police Force, and Deputy Commissioner Juanita Matanga of RSIPF. The meeting was also attended by Members' senior Police

Officers and Secretariat officials led by DG Mr Peter Forau. Issues of national, sub-regional and regional significance discussed by the Police Commissioners related to MSG participation in UN Peacekeeping, Cyber Crime, Domestic Violence, Emergency Management and Disaster Management. The experiences shared by particularly Vanuatu on their response to Cyclone Pam and lessons learnt from them enlightened Members given the Melanesian sub-region's increasing vulnerability to natural disasters. Key decisions from the Conference were presented to MSG Leaders, who subsequently signed the Agreement Establishing the Regional Police Academy, the Framework Agreement for the

VANUATU AGRICULTURE POLICY LAUNCHED

The Deputy Prime Minister and Minister for Trade, Hon, Moana Carcasses Kalosil, launched the Vanuatu Agriculture Sector Policy 2015-2030 in Port Vila on 26 June. The development of the Policy, supported by various partners including the EU through the Pacific Policy Program managed by SPC, involved nation-wide consultations led by the Department of Agriculture & Rural Development.

Members of Parliament including the former Minister for Agriculture, Hon. David Tosul, and the former Minister for Lands, Hon. Ralph Regenvanu, were in attendance, together with

Government officials and representatives of the private sector and of development partners. Farmers, including women and youth, were strongly represented and were duly recognised for their contributions to the country's national agricultural output.

Upon the invitation of DG Agriculture Howard Aru, PSDA Henry Sanday accompanied Dr Chris Addison, Senior Programme Coordinator, Knowledge Management from the Netherlandsbased Technical Centre for Agricultural and Rural Cooperation (CTA) to the launch. The Secretariat and CTA are exploring opportunities for collaboration

In support of youth development. the Secretariat hosted 12 young volunteers from New Caledonia who are co-sponsored by France Volontaire, the three Provincial Governments of New Caledonia and the French Government. Led by Mr Gael Audras, they are to serve as Teaching Assistants at French schools. Cultural Attachés at cultural centres and also to help in cooperation building activities on Efate, Vanuatu. from six months to three years, the attachments are to help develop youths through first-hand cross-cultural experiences and involvement in addressing local capacity needs.

The Secretariat also assisted the Sydney-based Lowy Institute for International Policy, with support from the Pacific Media Assistance Scheme and ANZ Bank, in convening the Melanesia New Voices: Investing in the Next Generation Dialogue in Port Vila on 23 June. The Secretariat helped with nominations that brought some of the 25 participating young and emerging leaders (five each from Fiji, New Caledonia, PNG, Solomon Islands and Vanuatu) to discuss their challenges and hopes for the region, and to explore opportunities for cooperation. NOUMEA TO HOST INVESTMENT ROADSHOW AND TRADE FAIR

"Fostering Investment Roadshows as a means to enhancing business to business linkages" is a commitment under the Port Moresby Declaration that the Secretariat is pursuing in order to improve intra-MSG trade and investment flows. Preparations are thus underway for holding the 3rd MSG Investment Roadshow and Trade Fair in Noumea, New Caledonia later this year. The Investment Roadshow is being scheduled for 18 November, while the Trade Fair is to follow the Roadshow on 19-20 November.

The Secretariat is working closely with the authorities in Noumea for the organisation of the Investment Roadshow and Trade Fair. Major items on their agenda include the programmes for both events, the level of participation, the number of booths and their allocations to Member countries, costing as well as opportunities for funding support.

Given the dynamics of the business environment at all levels, the Roadshow is to provide opportunities to the private sector as well as to senior Government officials and representatives of key institutions and development partners, to engage in meaningful dialogue on strategies for improving the overall climate for doing business in Member countries. Networking and matchmaking for trade and investment purposes will naturally be part of the programme, which will be further supplemented by opportunities that companies and institutions will have when exhibiting their goods and services at the Trade Fair.

The experiences shared by participants of the 2nd Roadshow and Trade Fair held in Port Moresby, PNG during November 2014 as well as the suggestions they have made to improve the events, have been useful to the Secretariat for its planning process. Additional feedback is therefore being encouraged, especially from other past participants who may have yet to submit their views and recommendations.

TRADITIONAL KNOWLEDGE REGULATORY REFORMS SUPPORTED

The implementation of the 2011 MSG Treaty on Traditional Knowledge and Expressions of Culture, which governs the regulation of access to traditional knowledge with equitable benefit sharing, involves a range of national capacity building activities such as the Traditional Knowledge Bill Workshop to be held in Honiara, Solomon Islands

on 03-07 August. The workshop will allow stakeholders from the public and private sectors and community groups including indigenous resource owners, to scrutinize the Solomon Islands Traditional Knowledge Bill that is due for tabling in Parliament later this year. This Bill is crucial to safeguarding cultural heritage and values from exploitation

and duplication, as well as to ensuring tangible and maximum benefits are acquired by rightful owners from the use of their traditional knowledge and culture.
